**Ninth Judicial District announces Rio Blanco County Court and Rio Blanco County Associate Court vacancies**  
*Commission sets date to select nominees*

The Ninth Judicial District Nominating Commission will meet via videoconference on June 15, 2020, to interview and select nominees for appointment by the governor to the offices of county judge and associate county judge for Rio Blanco County. The vacancies will be created by the retirement of the Hon. Laurie A. Noble. The vacancies will occur on July 2, 2020.

To be eligible, the applicant must be a qualified elector of Rio Blanco County at the time of investiture and have graduated high school or attained the equivalent of a high school education as indicated by the Department of Education, based upon the record made on the General Education Development test. Pursuant to C.R.S. 13-6-209, the associate county judge shall maintain his or her official residence and court chambers in the city of Rangely. The annual salary for the county judge position is \$33,159, and it is a 20 percent position. The annual salary for the associate county judge position is \$33,159, and it is also a 20 percent position. The initial term of office of a county judge is a provisional term of two years; thereafter, the incumbent county judge, if approved by the voters, has a term of four years.

The completed application must be e-mailed to the address listed in the instructions below no later than 4 p.m. May 29, 2020. Late applications will not be considered. Applicants must indicate whether they intend to apply for one or both vacancies. Any person wishing to suggest a candidate to fill the vacancy may do so by letter to be submitted to any member of the nominating commission, with a copy to the ex officio chair, no later than 4 p.m. May 22, 2020.

The members of the nominating commission for the Ninth Judicial District are: Scott Grosscup of Glenwood Springs; Lauren Maytin and Blanca O'Leary of Aspen; Sheryl Barto and Bonnie McLean of Carbondale; and Angela Strode of Rifle. The commission currently has one vacancy.

Instructions

1. The application form for a Colorado state court judgeship can be found on the Judicial Branch website at <http://www.courts.state.co.us/Careers/Judge.cfm>. Please be complete and thorough in answering the questions; and, if an answer to any question requires more space than provided, attach a separate sheet of paper for each question. Do not change the margins or font size on the application.
2. Your application materials should be prepared in the following manner:

The application should be saved as a PDF file (preferably in text searchable format. The electronic application does not need to contain a signature. If your application materials include multiple documents (i.e., cover letter, personal statement, reference letters) these documents should be combined into one single PDF document with the reference letters attached last.

You must submit the names of not fewer than three nor more than five individuals from whom you are requesting a letter of reference. Such letters of reference shall be strictly confidential. It is preferred that reference letters are included with your application submission. If they are submitted directly by the author, they should be submitted by email as described below in paragraph 3. It is your responsibility to ensure that all letters of reference are submitted by the filing deadline listed in paragraph 4.

3. Your application materials compiled as outlined above should be sent via email with **your name and Rio Blanco County Court in the subject line** with your materials attached as outlined above no later than 4 p.m. on **May 29, 2020** to the following email address:
